

### **Director of MRI Center at San Diego State University**

The Department of Psychology at the College of Sciences at San Diego State University invites applications for a tenured faculty position at the full professor level also serving in the role as Director of a new MRI Center. Candidates should hold a Ph.D. or equivalent degree in neuroscience, psychology, or related fields, and should have previous experience directing an MR imaging facility. Successful candidates will have made fundamental discoveries elucidating the function of the human brain using neuroimaging. Responsibilities of this combined position would be multifold and would encompass leadership service with excellence in research, teaching, and mentoring. In the role of the Director of the MRI Center, the successful candidate would be expected to provide strategic vision in building and directing a state-of-the-art imaging program for basic and translational research, and coordinate services provided to the SDSU imaging community. This academic position also includes maintaining research excellence, teaching graduate and undergraduate courses, and mentoring students. The candidate would play a key role in the Center for Clinical and Cognitive Neuroscience ([slhs.sdsu.edu/ccn/](http://slhs.sdsu.edu/ccn/)) whose missions are broadly aligned with research, educational, and service missions of the Psychology Department ([www.psychology.sdsu.edu](http://www.psychology.sdsu.edu)). Preference will be given to candidates of international reputation with an outstanding research record, experience with directing an imaging center, strong leadership and managerial skills, ability to establish and promote collaborative links across the University, a commitment to teacher-scholar model, and research and teaching interests extending to issues of culture and human diversity.
